FOOD VENDOR APPLICATION AND RULES

The following are the food vendor application and rules for the 2010 Wesley Chapel Craft Show. A *flat fee*, shown below, is paid to the Wesley Chapel Chamber of Commerce. You may sell your menu items at the price you set. There will be no more than two (2) vendors selling the same form of cuisine per category. Applications have a deadline (see rules page) however will be considered for approval on a "first come first serve basis". If you miss the deadline you can still participate however you will be subject to a **\$50.00** late filing fee and can only be considered and approved if no conflict with like menu. Applications must be completed in its entirety or may be returned. These fees are non refundable so please take the time for accuracy.

During the Battle of the Wing Contest, (Gladiators and Peoples Choice) all wings must be sold at a rate of two (2) wings for **\$1.00**. This is a mandate whether you're participating or not. This is necessary as part of your fee your automatically be qualified for People's Choice. This will also be applicable for the participating Gladiators!

Thank you for your participation in The 2010 Wesley Chapel Craft Show. The following rules and guidelines have been established to ensure fairness and safety to everyone.

The Craft Show will be held at the [Grove at Wesley Chapel](#). **The Grove at Wesley Chapel is located on Wesley Grove Boulevard, Wesley Chapel, FL 33544** www.groveshopping.com

- The hours of the show are **Saturday, October 16, 2010 from 10am – 5pm and Sunday, October 17, 2010 from 10am – 5pm**. You may set up any time after 6am both Saturday and Sunday.
- Open registration will be June 1, 2010 – July 30, 2010. Wesley Chapel Chamber members will be awarded spot first in event off conflict with non member. Booth tax included in fees. Each vendor is responsible for collecting and reporting their own sales tax.
- A late fee of **\$50.00** will be required should you miss application submission deadline of July 30, 2010. This includes members and non. Regardless of process this will be first come first serve and any conflicts will be resolved by Chair.
- Wesley Chapel Chamber members are afforded first rights of show. Any conflict will be resolved by Chair.
- Food Vendors are responsible for the proper disposal of their cooking oil/fat/grease.
- All participants must have a tent unless prior permission has been granted by the committee to forego your tent. The event will be on pavement, not grass. Your tent must be weighted on each leg to combat elements. You must provide your own tents, tables and chairs.
- Out of respect for fellow exhibitors, each participant must secure his/her booth for all weather conditions and large crowds. No participant may infringe on another's space.
- A **\$25.00** service fee will be charged on all return checks. The check amount plus the **\$25.00** fee is payable with cash, a cashier's check or money order.
